

Subject: Gainesville-Hall MPO, RTP Adoption and FY 16-19 TIP Approval Request

Dear Governor Deal:

On May 12, 2015, the Gainesville-Hall Metropolitan Planning Organization (GHMPO) Policy Committee passed a resolution adopting the Regional Transportation Plan (RTP) and associated FY 16 – FY 19 Transportation Improvement Program (TIP). The RTP and TIP update process began in 2014 and was developed in coordination among the GHMPO, local governments, and Georgia Department of Transportation (GDOT). The new RTP and TIP cover the newly expanded GHMPO planning boundary, which was amended in 2014 to include a portion of Jackson County. A copy of the GHMPO Policy Committee's signed resolution approving the RTP and FY 16-19 TIP is enclosed.

In accordance with Title 23, Part 450.324 (a), we respectfully request your approval of the proposed GHMPO FY 16-19 TIP. Once approved, we will notify the GHMPO and USDOT and amend the STIP to include GHMPO's new TIP.
