





Transit Program: FY 20 Year in Review

Grants & Contracts:

- Total contacts executed = 128
- CARES Act Supplemental Agreements = 91

Subrecipients:

- Small urban subrecipients = 9
- Brunswick preparing for FY 21 urban service
- Rural subrecipients = 82
- Regional Rural subrecipients = 5
 - Regional subs cover 33 counties + 3 rural municipalities
 - Add Murray Co to MATS in FY 21

Transit Fleet:

- Rural vehicles purchased = 63
- Current Rural fleet = 574 (+4 from FY 19)
- Macon-Bibb electric charging stations complete

Construction Projects:

- Atlanta Greyhound Terminal
- Albany Transit Center

Change in Ridership for GDOT Subrecipients - 2019 to 2020


