> The Eastern Federal Lands Highway Division (EFLHD) has developed a Mid-Year Update for the FY 2019-2022 Transportation Improvement Program (TIP) for transportation projects within Federal Lands. The Federal requirement under Title 23 U.S.C. § 204 requires that the TIP be developed as part of the transportation planning process for Federal Lands projects. The attached spreadsheet contains an overall list of those projects that are to be undertaken within your State. This updated, mid-year TIP reflects the addition of new projects or adjustments to project schedules and budgets made by our federal land management agency partners between October 1, 2018 and April 30, 2019. This updated list will soon be placed on the EFLHD website (http://www.efl.fhwa.dot.gov) to provide reference and information for citizens, affected public agencies, transportation agencies, private providers of transportation, and other interested parties.
