RE: Lobbying Activities Disclosure Form – LLL

The Federal Transit Administration and the Federal Office of Management and Budget (OMB) require quarterly reporting of any *lobbying* activities funded with **non-Federal funds** for all subrecipients receiving \$100,000 in Federal funds or making of any Federal loan exceeding \$ 150,000 each calendar year. When this occurs, OMB Standard Form LLL disclosure must be completed and sent to GDOT for filing with FTA. This requirement applies to subrecipients, subcontractors, and third party operators. **Use of Federal funds for lobbying is prohibited.** 

Qualifying activities required to be disclosed include the hiring of any third party lobbyist for the purposes of attempting to influence a covered Federal action. Please note that disclosure is not required for activities performed by the grantee's own regularly employed officers and employees. Covered Federal action is defined as:

- Awarding of any Federal contract or subcontract exceeding \$ 100,000.
- Making of any Federal grant or subrecipeint grant exceeding \$ 100,000
- Making of any Federal loan exceeding \$ 150,000.
- Entering into any Federal cooperative agreement exceeding \$100,000.
- Extension, continuation, renewal, amendment, or modification of any Federal contract, grant, or cooperative agreement exceeding \$100,000 or of a loan exceeding \$150,000.

Furthermore, quarterly reporting is required if any of the following qualifying events occur for lobbying activities related to a contract exceeding \$100,000 or load exceeding \$150,000.

- A cumulative increase of \$25,000 or more in the amount paid or expected to be paid for influencing or attempting to influence a
  "covered Federal action"
- A change in the person(s) attempting to influence such action
- A change in the officer(s), employee(s), or member(s) contacted to attempt to influence such action.

Form LLL will be required to be submitted to the Department on the following schedule when the above lobbying activities occur. Please submit OMB Form LLL to <a href="mailto:mnystrom@dot.ga.gov">mnystrom@dot.ga.gov</a> by the dates shown below if lobbying activities occur.

April 15<sup>th</sup> – For January 1<sup>st</sup> – Submit by: March 31

July 15<sup>th</sup> – For April 1 – Submit by: June 30<sup>th</sup>

October 15 – For July 1 – Submit by: September 30<sup>th</sup>

January 15 – For October 1 – Submit by: December 31<sup>st</sup>
