Note #1: Type I: Heat resistant non-woven polypropylene or polyester fabric capable of being placed smooth without wrinkles and being saturated with asphalt cement.

Type **II**: Heat resistant non-woven polypropylene or polyester fabric capable of being placed smooth without wrinkles and being saturated with asphalt cement. May have self-adhesive backing adhered to a film release liner.

Type **High**

Strength: A flexible water resistant high density asphaltic membrane laminated between two layers of high strength, heat resistant polypropylene or polyester geo-textile and be capable of being placed smoothed without wrinkles with mechanical device. May have self-adhesive backing adhered to a film release liner.

Note #2: Pavement Reinforcement Fabrics found on this QPL may be accepted by Manufacturer Certification as described in Section 881. Pavement Reinforcement Fabrics not found on this list require a Manufacturer Certification as described in Section 881 and shall be sampled and tested by the Office of Materials and Research before being allowed for project use.
